

**Official Rules (the "Official Rules") for
"SD Memory Card 256MD Giveaway (The "Promotion") by Hasimoto's
Company (the Promoter)"**

RULES-

PURCHASES OVER U\$15.99 IN AGGREGATE TOTAL BETWEEN AUGUST 01, 2005 to SEPTEMBER 30, 2005.

How to Enter -

Between May 15, 2005 and June 30, 2005 Promoter is conducting an online Promotion through which eligible individuals have an opportunity to win one (1) of two (2) SD Memory Cards 256MD. To be eligible to win, all entries must be received no later than midnight, June 30, 2005. LIMIT ONE ENTRY PER PERSON OR ORDER PLACED. Promoter will not verify receipt of entries.

Entries must be submitted by placing an order for our software at <http://www.ebizlinuxes.com>, <http://www.pocketgear.com>, <http://www.pocketland.de>, or <http://www.handango.com>. Incomplete entries will not be considered valid. IN EITHER CASE, ONLY ONE ENTRY PER PERSON, DUPLICATE ENTRIES WILL NOT BE ACCEPTED.

Mechanical/Automated Entries Prohibited -

Automated entries are prohibited, and any use of such automated devices will cause disqualification. Entry materials/data that have been tampered with or altered are void. Promoter and its advertising and promotions agencies are not responsible for lost, late, illegible, misdirected or stolen entries or transmissions, or problems of any kind whether mechanical, human or electronic. Once submitted, entries become the sole property of the Promoter and will not be returned. In case of dispute as to identity of a winner, such entry will be declared as being submitted by the registered user of the email account at the time the entry was submitted, and if a prize is won, and such registered user is a valid entrant, the prize will be awarded to such registered user.

Participants may not enter using multiple names. Any participant who attempts to enter with multiple identities, or uses any other device to enter multiple times, other than as permitted.

Eligibility -

Proof of Identity -

Promoter reserves the right to require winner to submit proof that they are the authorized winner by submitting legal identification (state id or passport).

Drawing and Awarding of Prizes -

The Winner will be determined by a random drawing from all eligible entries received, to be held after the end of the promotion period at the Promoter's offices. All decisions of the Promoter are final and binding. Odds of winning depend on the number of eligible entries received. The winner will be notified by email within twenty (20) days of the drawing. Winner will have twenty (20) days from notification to accept the prize by e-mail. The Promoter is not responsible for and shall not be liable for any late, lost, or misdirected notification, or for winner's unsuccessful efforts to claim any prize.

If potential winner cannot be reached within twenty (20) calendar days from the first notification attempt, then such person shall be disqualified and an alternate winner will be selected.

Release of Liability -

Winner may be required to sign and return a release of liability, declaration of eligibility, and where lawful, publicity consent agreement, all within twenty (20) days of acknowledged notification. By accepting and/or using prize, the winner agrees to the use of his/her name, voice and/or likeness for the purpose of advertising, trade, or promotion without further compensation, unless prohibited by law. If a selected winner cannot be contacted, is ineligible, fails to claim a prize, or fails to timely return the completed and executed declaration and releases as required, prize may be forfeited and an alternate winner will be selected.

Prize Details -

Two SD Memory Cards will be awarded for this Promotion. The gift certificates will vary in value from Hong Kong 300.00 to Hong Kong Dollars \$650.00. There also may be consolation prizes to be determined later by the "promoter". These prizes will not exceed Hong Kong Dollars 650.00 each.

The Prize winners will be chosen randomly from among all valid entries received during the term of the Promotion. The Prizes will be shipped directly to the Prize winner's home or e-mail address. In the event Promoter is unable to ship the Prizes directly to Prize winner's home address due to postal restrictions or other circumstances beyond the control of Promoter, or if the described Prizes are otherwise unavailable for any reason whatsoever, Promoter reserves the right to substitute a prize of like value. The winner is not entitled to any alternative prizes and the prizes are nontransferable. The Prize winner(s) are responsible for reporting and payment of all taxes (including federal, state and local, if any) on account of the prizes. Return of any prize or prize notification as "undeliverable" will result in disqualification and an alternate winner may be selected. All prizes claimed will be awarded. Prize is not transferable. Only one prize per family or household will be awarded. If winner is deemed a minor in his/her state of residence, prize will be awarded in the name of a parent or legal guardian.

By participating in the Promotion, each participant agrees, to release and hold Promoter and the employees, officers, directors, shareholders, agents, representatives of Promoter, its parent companies, affiliates, subsidiaries, advertising, promotion, and fulfillment agencies, and legal advisors, harmless from any and all losses, damages, rights, claims and actions of any kind in connection with the Promotion or resulting from acceptance, possession, or use of any prize, including without limitation, personal injury, death, and property damage, and claims based on publicity rights, defamation, or invasion of privacy.

Venue -

The prevailing party in any legal proceeding pertaining to this Promotion shall be entitled to all attorney's fees and costs incurred by the participation in the legal proceeding.
